**A BILL**

**For an ordinance authorizing a transfer of cash from the “National Western Complex(NWC)/Colorado Convention Center (CCC) and Other Tourism Projects Fund” and the “Excise Tax Base Account” and making an appropriation to the “Colorado Convention Center” Grant and Other Money Projects Fund as part of the Series 2016 Bond financing structure.**

**WHEREAS**, this request seeks approval of the transfer and appropriation of excess excise tax revenue from the Series 2016 2C dedicated tax flow of funds of \$4,791,388; and

**WHEREAS**, the funds will be held in reserve for future CCC financings;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** There is hereby authorized the transfer of cash from the Grant and Other Money Projects Fund Accounting No. 38000 to the “Colorado Convention Center” Grant and Other Money Projects Fund the amount indicated in the following tabulation:
