- Crime Prevention and Control Commission has contracted with the Colorado Coalition for the Homeless to provide Assertive Community Treatment “ACT” to mentally ill-homeless persons in the Court to Community court intervention program. The proposed contract provides for a one-year agreement extension (FY2011) that cumulatively exceeds the threshold contained in Section 3.2.6(E) of the Charter requiring City Council approval. The proposed one-year amendment cost is \$144,000 and the total cumulative cost will be \$720,000.
