A BILL

For an ordinance creating a Fund Number in the Grant Projects Fund for the “Denver Water Intergovernmental Agreement” project and the funding therefor.

WHEREAS, Ordinance 843 of Series 2015 approves an Intergovernmental Agreement between the City and County of Denver and the Denver Board of Water Commissioners; and

WHEREAS, this agreement provides for increasing the efficient use of water on Denver parks and golf courses;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. The payments made by the Denver Board of Water Commissioners to the City pursuant to and under the Intergovernmental Agreement shall be deposited into the Treasury of the City and credited to Special Fund No. 38000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.

Section 2. A new Fund is hereby established in the Grant Projects Fund, Accounting No. 38000, for the project indicated in the following tabulation:
