This contract amendment will allow the City to receive and expend federal money for the reconstruction of the intersection at Colfax Ave, Welton St and Galapago St. The project approved as one of the City’s projects for the DRCOG 2008-2013 TIP program.

This IGA will allow the City to complete the design, environmental investigation, land purchase and construction for the reconstruction of the intersection at Colfax/Welton/Galapago. The project will realign the 45 degree signalized intersection to improve traffic flow and make for safer pedestrian movements. This amendment allows federal funds to be spent for R.O.W. acquisition and construction.
