5 **Laying out, opening and establishing as part of the city street system, as part**
6 **of 8th Place, certain real property in Lowry Filing No. 15.**

8 **WHEREAS**, the Manager of Public Works of the City and County of Denver has found and
9 determined that the public use, convenience and necessity require the laying out, opening and
10 establishing as public streets designated as part of the system of thoroughfares of the municipality
11 those portions of real property hereinafter more particularly described, and, subject to approval by
12 resolution has laid out, opened and established the same as a public street;

13 **NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF**
14 **DENVER:**

16 **Section 1.** That the action of the Manager of Public Works in laying out, opening and
17 establishing as part of the system of thoroughfares of the municipality the following described
18 portion of real property situate, lying and being in the City and County of Denver, State of
19 Colorado, to wit:

20 **8th Pl.**, from the northeast corner of lot 7, block 2, Lowry Filing No. 15, northwesterly to
21 the southeast corner of lot 6, block 1, westerly along the north boundary of 8th Pl., to the
22 southwest corner of lot 11, block 1, then southwesterly to the northwest corner of lot 1,
23 block 2, then southeasterly to the northeast corner of lot 7, block 2, the land in the
24 following described area:

25 **Tract B, Lowry Filing No. 15, City and County of Denver, State of Colorado;**

27 be and the same is hereby approved and said real property is hereby laid out and established and
28 declared laid out, opened and established as part of 8th Place in Lowry Filing No. 15.

29 **Section 2.** That the real property described in Section 1 hereof shall henceforth be part
30 of 8th Place in Lowry Filing No. 15.
