## 5. General description or background of proposed request. Attach executive summary if more space needed:

In alignment with the City and County of Denver's and Vision 100's values, Denver International Airport (DEN) developed the voluntary Excellence in Service (EIS) program for concessionaires. This program motivates and rewards top-performing concessionaires by offering a 3-year contract extension to those who qualify. EIS scoring is based on assessments in Equity, Diversity, Inclusion, and Accessibility (EDIA), Airport Certified Disadvantaged Business Enterprise (ACDBE), Environmental Sustainability, and Customer Service. To receive the contract extension, concessionaires must achieve a score of 90% or higher across these categories. Concessionaires must also maintain contract compliance. The award can only be earned one-time, and after the extended contract term, the space will be re-bid through the Request for Proposal (RFP) process.

These provisions are to bring the contracts into standards with the current concessions contract and to ensure that our concession spaces remain regulatory compliant.
