4 **A RESOLUTION**

5 **Laying out, opening and establishing as part of the City street system a parcel**
6 **of land as a public alley bounded by North Broadway, West 3rd Avenue, North**
7 **Acoma Street and West 4th Avenue.**

8 **WHEREAS**, the Executive Director of Public Works of the City and County of Denver has
9 found and determined that the public use, convenience and necessity require the laying out, opening
10 and establishing as a public alley designated as part of the system of thoroughfares of the
11 municipality that portion of real property hereinafter more particularly described, and, subject to
12 approval by resolution has laid out, opened and established the same as a public alley;

13 **BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

14 **Section 1.** That the action of the Executive Director of Public Works in laying out, opening
15 and establishing as part of the system of thoroughfares of the municipality the following described
16 portion of real property situate, lying and being in the City and County of Denver, State of Colorado,
17 to wit:

19 A PARCEL OF LAND CONVEYED BY SPECIAL WARRANTY DEED TO THE CITY AND
20 COUNTY OF DENVER, RECORDED ON 6/29/2018 AT RECEPTION NUMBER 2018080195 IN
21 THE CITY AND COUNTY OF DENVER CLERK AND RECORDER’S OFFICE, STATE OF
22 COLORADO, MORE PARTICULARLY DESCRIBED AS FOLLOWS:

23 THE EASTERLY 1.50 FEET OF LOTS 1 THROUGH 5 AND THE NORTHERLY 3 FEET OF LOT
24 6, BLOCK 12, BROADWAY TERRACE SUBDIVISION, LOCATED IN THE NORTHWEST
25 QUARTER OF SECTION 10, TOWNSHIP 4 SOUTH, RANGE 68 WEST OF THE SIXTH
26 PRINCIPAL MERIDIAN, CITY AND COUNTY OF DENVER, STATE OF COLORADO.

27 SAID PARCEL CONTAINS 0.009 ACRES, 380 SQUARE FEET, MORE OR LESS.
