EXECUTIVE SUMMARY

The purpose of the ordinance is to approve the service plans for the formation and establishment of two (2) Title 32 metropolitan districts located for redevelopment of a portion of the former ASARCO site located in both Denver and Adams County generally at the northwest corner of East 51st Street to East 55th Street and Washington Street: **Globeville Commerce Center Metropolitan District #1 and Globeville Commerce Center Metropolitan District #2**. The location is a 78-acre commercial redevelopment approximately 15 acres are located in Denver. The site is the former ASARCO smelter site with no residential development allowed.

The Service Plans address public infrastructure financing within a multi-jurisdictional boundary of Adams County and the City and County of Denver. Districts #1 and #2 located in Denver and are being approved in tandem with Adams County Service Plans #3 and #4. The Service Plans of Adams County are substantially the same as Denver’s Service Plans. Adams County has agreed to include the City of Denver’s requirements of Prevailing Wage, Small or Disadvantaged Business Enterprises, Discrimination, and Public Art.

The Districts will provide for the construction, financing, operation and maintenance of certain public improvements which are necessary for the successful implementation the redevelopment.

The Financing Plan anticipates issuing Bonds to fund approximately \$15 million of estimated infrastructure costs over time including principal and interest. The Service Plan has a mill levy cap of 50 mills for debt and a total debt cap of all 4 Districts of \$25M. The Service Plan also anticipates levying 10 mills for operations.
