# The proposed change amends the Classification and Pay Plan by adding Semi-Tractor Trailer Operator at pay grade 616-J.

The Public Works Street Maintenance Division requested a new classification specifically for semi-tractor trailer operators to help the Street Maintenance Division assign and recruit for duties and responsibilities specific to hauling materials and equipment to and from roadway and street repair and maintenance projects.

Currently, the duties and responsibilities specific to a semi-tractor trailer operator requiring a Class A Commercial Driver's License, which is combined with the heavy equipment operator classification, which requires a Class B Commercial Driver's License.

The semi-tractor trailer operator is responsible for hauling asphalt to worksites and transporting debris to dumpsites, and transporting vehicles and equipment to and from worksites; whereas, the heavy equipment operator is responsible for operating large construction equipment specific to road building and paving.

# Synopsis:

The Public Works Street Maintenance Division requested a new classification specifically for semi-tractor trailer operators to help the Street Maintenance Division assign and recruit for duties and responsibilities specific to hauling materials and equipment to and from roadway and street repair and maintenance projects.

Currently, the duties and responsibilities specific to a semi-tractor trailer operator requiring a Class A Commercial Driver's License, which is combined with the heavy equipment operator classification, which requires a Class B Commercial Driver's License.

The semi-tractor trailer operator is responsible for hauling asphalt to worksites and transporting debris to dumpsites, and transporting vehicles and equipment to and from worksites; whereas, the heavy equipment operator is responsible for operating large construction equipment specific to road building and paving.

# Pay Rationale:

Based on internal equity, the Semi-Tractor Trailer Operator classification will have the same pay grade as the Heavy Equipment Operator Classification at 616-J since these two classifications are being separated out for specialization of recruitment qualifications and job assignment purposes.

#### **Employee Impact:**

Ten employees will be transferred from the Heavy Equipment Operator classification to the Semi-Tractor Trailer Operator classification.

#### **Budget Impact:**

There is no budget impact as incumbents will move pay-to-pay within the same pay grade from Heavy Equipment Operator (616-J) to Semi-Tractor Trailer Operator (616-J).

#### **Organizational Data:**

This position typically reports to a Crew Supervisor or Operations Supervisor depending on the nature of the work unit.

### **Effective Date Rule:**

OHR Section 7-37 (A) – If it is determined, as a result of an audit or a maintenance study, that changes to the classification and pay plan are necessary, the effective date of any resulting changes to the classification and pay plan shall be the beginning of the first work week following approval by the Mary or by the City Council over the Mayor's veto. Provisional classifications resulting from changes to the classification and pay plan may be used upon approval by the Board, but use for longer than six months is contingent upon City Council approval.
