Charter Section § 2.2.6 (D) requires consent of City Council for the Mayoral appointment of Charter officers. The Mayor has selected Nicole Doheny to serve as CFO for the City and County of Denver. The Charter department of Finance has a broad portfolio and is responsible for all powers and duties related to the financial operations and interests of the City. This includes developing and managing a budget of over \$1 billion annually; managing the city's year over year revenues and spending, bond rating, and debt ratios; capital improvement funding; collection of all city taxes and revenues; citywide payroll; assessing the value of over 200,000 taxable properties; managing all city-owned real estate transactions; overseeing all special districts; overseeing the city's banking services; managing the city's cash management, including the \$3 billion investment portfolio; managing the Dept. of Motor Vehicles; and overseeing the city's risk management, including workers' compensation.

Nicole Doheny is a government finance professional and a registered municipal advisory principal advising cities, states, and other public agencies across the United States in support of major strategic initiatives. Doheny comes to the City and County of Denver after serving as a Senior Managing Director with Ernst & Young Infrastructure Advisors (EY), an affiliate of Ernst & Young LLP, where she has been a part of the government and public sector practice since 2013.

Prior to joining EY, she was part of the public finance team at Lehman Brothers and Barclays Capital, working directly with state and local governments on capital strategies and public debt issuances.
