4 **A RESOLUTION**

6 **By the Council of the City and County of Denver, sitting ex officio as the Board of**
7 **Directors of the Denver 14th Street General Improvement District, approving a Work Plan,**
8 **adopting a Budget, imposing Capital Charges and Maintenance Charges, and making**
9 **appropriations for the 2015 Fiscal Year.**

11 **WHEREAS**, the Denver 14th Street General Improvement District (the “District”) was created by
12 Denver Ordinance No. 464, Series of 2009, (“Creation Ordinance”) and said Creation Ordinance
13 recognized the Council of the City and County of Denver as the Board of Directors of the District (the
14 “Board of Directors”), pursuant to C.R.S. 31-25-609, C.R.S.; and,

15 **WHEREAS**, the Board of Directors is authorized to approve the Work Plan and Budget and impose
16 Capital Charges and Maintenance Charges; and,

17 **WHEREAS**, Denver Ordinance No. 463, Series of 2009, established a District Advisory Board (the
18 “Advisory Board”) for the District, and specified that such Advisory Board should, subject to the approval of
19 the Board of Directors, conduct and manage certain affairs of the District as the authorized agent of the
20 Board of Directors including certain financial and legal affairs; and,

21 **WHEREAS**, the said Ordinance No. 463 also calls for the Advisory Board to prepare, hold a public
22 hearing on, deliver and recommend to the Board of Directors, at least once a year, a Work Plan, Budget,
23 Capital Charges, and Maintenance Charges (as such terms are defined in the Creation Ordinance) for the
24 next succeeding fiscal year; and,

25 **WHEREAS**, following due notice, the Advisory Board has held a public hearing on September 16,
26 2014, on the proposed Capital Charges, Maintenance Charges, Work Plan and Budget, and has prepared,
27 delivered and recommended to the Board of Directors for its approval the District Work Plan, Budget,
28 Capital Charges, and Maintenance Charges for the 2015 Fiscal Year; and,

29 **WHEREAS**, in an election held on November 3, 2009, the eligible electors of the District approved
30 ballot issues authorizing the creation of the District, the collection, retention and spending of revenues in
31 the amounts not less than as specified in the proposed 2015 Work Plan, Budget and other matters; and,

32 **NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER,**
33 **IN ITS EX OFFICIO CAPACITY AS THE BOARD OF DIRECTORS OF THE DENVER 14TH STREET**
34 **GENERAL IMPROVEMENT DISTRICT:**

36 **Section 1.** That the 2015 Work Plan and Budget for the District as filed in the Office of the City
37 Clerk, ex-officio Secretary of the District on the 1st day of October, 2014, in File No. 2009-629-W be and
38 hereby is adopted and approved.

39 **Section 2.** The sum of money identified for each fund in the 2014 Budget for expenditure in the
40 2015 Fiscal Year is hereby appropriated for such purpose.
