## EXECUTIVE SUMMARY

The purpose of the resolution is to set a public hearing to approve the Rock Drill Urban Redevelopment Plan.

Approving the Urban Redevelopment Plan will establish the Rock Drill Urban Redevelopment Area and create the respective Rock Drill Sales Tax and Property Tax Increment Areas to assist in the process of redevelopment of an underutilized and blighted site. The urban redevelopment project will revitalize the Rock Drill Urban Redevelopment Area through the adaptive reuse of existing buildings and the transformation of the underutilized Rock Drill site into an accessible, mixed-use development with neighborhood-serving retail and community space. The Denver Urban Renewal Authority ("DURA"), in coordination with the City's Department of Finance and Department of Community Planning and Development, is seeking to establish the Rock Drill Urban Redevelopment Area to support the proposed redevelopment through the approval of the Rock Drill Urban Redevelopment Plan.

Staff with the City and DURA are drafting the Rock Drill Urban Redevelopment Plan and related Cooperation Agreement authorizing the creation of the Rock Drill Urban Redevelopment Area and the use of Tax Increment Financing by DURA. State law requires a public hearing be held prior to City Council's consideration of establishing an urban redevelopment plan, with 30 days' prior notice. It is anticipated that this hearing would be conducted on September 15, 2025.

DURA will be asking Finance & Business Council Committee to approve the resolution on consent at the July 29, 2025 meeting. A presentation to the Finance & Business Committee for the approval of the Rock Drill Urban Redevelopment Plan will be scheduled for August 26, 2025, ahead of the anticipated September 15, 2025, public hearing at City Council.
