BR16-0443 Adopts the Westwood Neighborhood Plan as a part of the City's Comprehensive Plan in Council District 3.

BR16-0442 Rezones property at 3515 South Tamarac Drive, 3525 South Tamarac Drive, 3535 South Tamarac Drive, and 3545 South Tamarac Drive from B-1 and B-3 (Former Chapter 59 Code) to S-MX-3 in Council District 4.

RR16-0441 Approves a concessionaire contract with Work Options for Women for up to 4% in revenue and until 6-30-19 to provide concessions and cafeteria services for Denver Department of Human Services Castro building at 1200 Federal Boulevard, in Council District 3.
