Approves the Mayoral appointment of Nikki Mohaupt to the Federal Boulevard Business Improvement District Board of Directors for a term effective immediately and expiring 12-31-17 or until a successor is duly appointed. The Committee approved filing this resolution by consent on 4-21-16.

CR16-0285 A resolution approving a proposed Lease Agreement between the City and County of Denver and Bradley Donuts, LLC to lease 700 14th Street.

Approves a ten-year \$316,135.59 revenue contract with Bradley Donuts, LLC to lease 700 14th Street adjacent to the Colorado Convention Center in Council District 9 (FINAN 2016236309). CB16-0256 A bill for an ordinance dissolving the 9th Avenue Business Improvement District.

Approves the dissolution of the 9th Avenue Business Improvement District in Council District 5. IF ORDERED PUBLISHED, A PUBLIC HEARING WILL BE HELD ON THIS ITEM. REFER TO THE "PENDING" SECTION OF THE FUTURE COUNCIL MEETING AGENDAS FOR THE DATE. The Committee approved filing this bill by consent on 4-14-16.

Finance & Services

CB16-0254 A bill for an ordinance amending Article III, Chapter 16 of the Denver Revised Municipal Code relating to the collection of the emergency telephone charge.

Authorizes the Department of Finance to collect E911 surcharges and updates the process for reporting and remittance of this emergency telephone charge fee. The Committee approved filing this bill by consent on 4-14-16.

CB16-0260 A bill for an ordinance amending the City Retail Sales Tax Article, Article II, Chapter 53 of the Denver Revised Municipal Code and the City Use Tax Article, Article III, Chapter 53 of the Denver Revised Municipal Code to provide that each calculation on the taxpayer's return shall be rounded to the nearest whole dollar.

Amends provisions of the Denver Revised Municipal Code to require that calculations on the taxpayer's return for retail sales and city use tax be rounded to the nearest whole dollar. The Committee approved filing this bill by consent on 4-14-16.

CB16-0265 A bill for an ordinance designating certain properties as being required for public use and authorizing use and acquisition thereof by negotiation or through condemnation proceedings of easements and other interests, including any rights and interest related or appurtenant to such properties so designated, as needed for the installation of upgraded traffic signals and ADA curb ramps along Colorado Boulevard at the intersections of Louisiana Avenue and Arkansas Avenue.

Authorizes negotiation, purchase, or condemnation of six (6) permanent easements to install traffic lights and American with Disabilities Act-compliant ramps along Colorado Boulevard at the intersections of Louisiana and Arkansas avenues in Council District 6. The Committee approved filing this bill by consent on 4-21-16.

CB16-0279 A bill for an ordinance authorizing and approving (i) the use of an amount not to exceed \$40,000,000 of Private Activity Bond Volume Cap Allocation for the purpose of making a mortgage credit certificate election; and (ii) the MCC Program Administration Agreement, Lender Participation Agreement and the MCC Program Guidelines.

Authorizes and approves the use of an amount not to exceed \$40 million of Private Activity Bond Volume Cap Allocation for the Mortgage Credit Certificate Program and approves related agreements and program guidelines. The Committee

approved filing this bill by at its meeting on 4-19-16.

CB16-0292 A bill for an ordinance amending Chapters 32 and 53 of the Denver Revised Municipal Code relating to retail use tax and lodger's tax licenses, occupational privilege tax registration, and the filing frequency for occupational privilege and lodger's tax returns.

Changes the Denver Revised Municipal Code relating to retail use tax and lodger's tax licenses, occupational privilege tax registration, and the filing frequency for lodger's tax returns. The Committee approved filing this bill by consent on 4-21-16.

CB16-0271 A bill for an ordinance relinquishing three easements reserved by Ordinance No. 151, Series of 1953, Ordinance No. 97, Series of 1939, and by a Deed of Easement, recorded with the Denver Clerk & Recorder on August 20, 1938 at Book 5231, Page 369, located at 1812 35th Street.

Relinquishes three easements at 1812 35th Street in Council District 9. The last regularly scheduled Council meeting within the 30-day review period is on 5-23-16. The Committee approved filing this bill by consent on 4-21-16.

CB16-0266 A bill for an ordinance approving a proposed Third Amendatory Agreement between the City and County of Denver and State of Colorado Judicial Department, for the community-based violence prevention demonstration program.

Amends a contract with the Colorado State Judicial Department extending the end date by one year to 12-3-16 and adding \$48,411.84 to the contract for a total contract amount of \$606,520.84 to continue the work of the Gang Reduction Initiative of Denver (GRID) program (SCITY-201100301-03). The last regularly scheduled Council meeting within the 30-day review period is on 5-23-16. The Committee approved filing this bill by consent on 4-21-16.

CB16-0177 A bill for an ordinance adding a new Article XIII of Chapter 24 of the Revised Municipal Code of the City and County of Denver regarding use of graywater.

Amends the Denver Revised Municipal Code to add a new Article XIII of Chapter 24 allowing for the beneficial reuse of graywater within the City. The Committee approved filing this bill at its meeting on 4-12-16.

CB16-0257 A bill for an ordinance amending Article II of Chapter 4 of the Denver Revised Municipal Code relating to prevention and control of nuisance odors.

Amends Article II of Chapter 4 of the Denver Revised Municipal Code relating to prevention, control, and abatement of nuisance odors. The Committee approved filing this bill at its meeting on 4-12-16.
