This amendment adds \$900,000 to an agreement with the Colorado Poverty Law Project to provide eviction legal assistance to eligible households in the City and County of Denver. Colorado Poverty Law Project will provide eviction prevention legal advice and representation, housing navigation, young adult outreach, referrals, and self-help eviction prevention services to eligible residents at or below 80% of the area median income (AMI). This \$1,355,152 contract is expected to serve approximately 5,575 households.
