**CR12-0317 A resolution granting a revocable permit to BNSF Railway Company, to encroach with various items into the right-of-way at 44th Avenue, east of Sherman Street. (LAND USE, TRANSPORTATION & INFRASTRUCTURE)**

Grants a revocable permit to BNSF Railway Company to encroach into the public right-of-way with a private storm sewer and man hole in 44th Ave. just east of Sherman in Council District 9. The Committee approved filing this resolution by consent on 4-26-12.

## **Business, Workforce & Sustainability**

**CB12-0294 A bill for an ordinance approving a proposed First Amendment to Agreement between the City and County of Denver and Qwest Communications Company LLC, now known as Century Link, related to on-call technology systems support services at Denver International Airport. (BUSINESS, WORKFORCE & SUSTAINABILITY)**

Adds \$1 million to the current \$500,000 contract with CenturyLink through June 2014 (CE15006) for on-call technical systems support including analytic, project management, infrastructure, voice and data network services and operations systems design and implementation for the airport. The last regularly scheduled Council meeting within the 30-day review period is on 5-21-12. The Committee approved filing this bill by consent on 4-19-12.

**CB12-0295 A bill for an ordinance approving a proposed First Amendatory Agreement between the City and County of Denver and Woolpert, Inc., concerning professional planning services at Denver International Airport. (BUSINESS, WORKFORCE & SUSTAINABILITY)**

Approves an 18-month no-cost extension through December 31, 2013 for the current \$1,584,417 contract with Woolpert (# CE92068) to develop a new datum and coordinate system as required by the Federal Aviation Agency for the airport. The last regularly scheduled Council meeting within the 30-day review period is on 5-21-12. The Committee approved filing this bill by consent on 4-19-12.

## **Government & Finance**

**CB12-0258 A bill for an ordinance amending the classification and pay plan for employees in the Career Service and for certain employees not in the Career Service. (GOVERNMENT & FINANCE)**

Abolishes Public Safety Inspector (621-T) and creates the following new classes: Combination Inspector I (622-T), Combination Inspector II (624-T), Chief Combination Inspector (812-T) and Trades Inspector (621-T) as part of the Career Service. The Committee approved filing this bill by consent on 4-19-12.

**CB12-0292 A bill for an ordinance approving a proposed Master Purchase Order between the City and County of Denver and Wagner Equipment Co., for the delivery of stock parts for the City's Caterpillar™ Heavy Equipment. (GOVERNMENT & FINANCE)**

Adds \$710,000 to the Master Purchase Order with Wagner Equipment Company for OEM Caterpillar™ Heavy Equipment parts and components. The last regularly scheduled Council meeting within the 30-day period is on 5-21-12. The Committee approved filing this bill by consent on 4-19-12.

**CB12-0302 A bill for an ordinance making rescissions and transfer appropriations in the General Fund, authorizing expenditures and transfers in the General Government Special Revenue Fund, and making**

**appropriations in the Capital Improvements and Capital Maintenance Fund. (GOVERNMENT & FINANCE)**

Transfers \$104,748 of unspent 2011 appropriations to the City General Fund, reappropriates \$111,219 of unspent 2011 appropriations to various City Council special revenue funds, corrects a misappropriation totaling \$47,700 by transferring it to the "City Council All Special Revenue fund", and expends \$25,000 from City Council District 6 Special Revenue Fund, and \$10,000 from City Council District 9 Special Revenue Fund for capital improvement projects. The Committee approved filing this bill by consent on 4-26-12.

**Health, Safety, Education & Services**

**CB12-0022 A bill for an ordinance approving an access agreement with Altus Consulting, LLC, a consultant for the Colorado Division of Oil and Public Safety, under which State's consultant will have the right to access City-owned property at 2013 South Osage Street to conduct remediation activities. (HEALTH, SAFETY, EDUCATION & SERVICES)**

Grants access to Altus Consulting, LLC, a contractor for the Colorado Division of Oil and Public Safety (OPS), to conduct remediation operations at the City-owned leaking underground storage tank site located at 2013 S. Osage Street utilizing money available from the OPS reimbursement fund program. This is a no-cost contract. The last regularly scheduled Council meeting within the 30-day review period is on 5-21-12. The Committee approved filing this bill by consent on 1-5-12.

**CB12-0180 A bill for an ordinance approving a proposed Amendatory Agreement between the City and County of Denver and Denver Rescue Mission to modify the scope of work to be performed. (HEALTH, SAFETY, EDUCATION & SERVICES)**

Amends the Denver Rescue Mission contract with the Department of Human Services to reduce the "bed days" available by 485 days where services are provided to homeless individuals. This is a no cost amendment, the contract cost remains at \$613,200 (CE04013). The last regularly scheduled Council meeting within the 30-day review period is on 5-21-12. The Committee approved filing this bill at its meeting on 3-20-12.

**CB12-0199 A bill for an ordinance approving an Agreement with the Colorado Nonprofit Development Center to act as the fiscal agent for the Ryan White Care Act Part A funding. (HEALTH, SAFETY, EDUCATION & SERVICES)**

Approves a \$20,000 contract with Colorado Nonprofit Development Center to permit them to act as the fiscal agent for the disbursement of Ryan White CARE Act Part A funding in the amount of \$7,540,660 for the period of March 1, 2012 to February 28, 2013, received from the U.S. Department of Health & Human Services through the Health Resources & Services Administration (ENVHL-201204934-00). The Committee approved filing this bill by consent on 3-22-12.

**Land Use, Transportation & Infrastructure**

**CB12-0241 A bill for an ordinance prohibiting unauthorized camping on public or private property. (LAND USE, TRANSPORTATION & INFRASTRUCTURE)**

Approves a prohibition on unauthorized camping on public and private property and establishes general officer protocol, including determination if any medical or human services assistance is needed and seeking such assistance, prior to any citation or arrest. The Committee approved filing this bill at its meeting on 4-24-12.

**CB12-0261 A bill for an ordinance changing the zoning classification for 3901 Fox Street and 3965 Fox Street. (LAND USE, TRANSPORTATION & INFRASTRUCTURE)**

Changes the zoning classification from I-A, UO-2 (light industrial, billboard overlay) to C-MS-12 (urban center context, main street, 12 stories) to allow for development consistent with the 41st and Fox Station Area Plan at 3901 and 3965 Fox in Council District 9. A PUBLIC HEARING WILL BE HELD AT LEAST FOUR WEEKS AFTER PUBLICATION. The Committee approved filing this bill at its meeting on 4-17-12.

**CB12-0264 A bill for an ordinance changing the zoning classification for 1804 South Pearl Street. (LAND USE, TRANSPORTATION & INFRASTRUCTURE)**

Changes the zoning classification from U-TU-C (urban neighborhood context, two-unit, 55 sf min. lot) to U-MS-2X (urban neighborhood context, small scale imbedded mixed use on local street) at 1804 S. Pearl in Council District 7. A PUBLIC HEARING WILL BE HELD AT LEAST FOUR WEEKS AFTER PUBLICATION. The Committee approved filing this bill at its meeting on 4-17-12.

**CB12-0296 A bill for an ordinance vacating a portion of right-of-way at the corner of 32nd Avenue and a cross alley near Tejon Street, with reservations. (LAND USE, TRANSPORTATION & INFRASTRUCTURE)**

Vacates a portion of public right-of-way to the adjacent property owner at the corner of W. 32nd Ave and the alley near Tejon in Council District 9. The Committee approved filing this bill by consent on 4-19-12.

**CB12-0297 A bill for an ordinance approving a proposed Agreement between the City and County of Denver and AECOM Technical Services, Inc., to procure a study of the validity and appropriateness of a new type of regional trip-based model through the East Colfax corridor. (LAND USE, TRANSPORTATION & INFRASTRUCTURE)**

Approves a \$700,000 contract with AECOM Technical Services with a term through 6-30-14 to complete an assessment of the Focus Model under a \$2 million Federal Transit Administration Alternatives Analysis Grant for the East Colfax Corridor in Council Districts 5, 8 and 10. The last regularly scheduled Council meeting within the 30-day review period is on 5-21-12. The Committee approved filing this bill by consent on 4-19-12.

Approves an agreement with the Denver Cutthroats, LLC, a minor league hockey team, for use of the Denver Coliseum to practice and play games for about \$1 million in various revenues to the City. The last regularly scheduled Council meeting within the 30-day review period is on 5-14-12. The Committee approved filing this bill at its meeting on 4-11-12.

**CB12-0271 A bill for an ordinance approving a proposed Second Amendment to Cargo Facilities Lease Agreement between the City and County of Denver and Air General, Inc. concerning the operation of a Cargo Facility at Denver International Airport. (BUSINESS, WORKFORCE & SUSTAINABILITY)**

Extends the \$165,000 lease with Air General's Support Facilities for space for the British Airways cargo handler through the end of 2012. The last regularly scheduled Council meeting within the 30-day review period is on 5-14-12. The Committee approved filing this bill by consent on 4-12-12.

Approves a license and agreement with the Colorado Department of Public Health and Environment/Air Pollution Control Division to install and operate an air monitor facility at Fire Station 20 in Council District 3 (FIRES-201204935).
