4 **A RESOLUTION**

5 **To approve the inclusion of overlapping services and facilities**
6 **between the Central Platte Valley Coordination District and the**
7 **Central Platte Valley Metropolitan District.**

9 **WHEREAS**, City Council approved on November 26, 2012 the service plan for
10 the Central Platte Valley Coordination Metropolitan District (the "Coordination District");
11 and

12 **WHEREAS**, the City Council acknowledges that the boundaries of the
13 Coordination District overlap with the boundaries of the existing Central Platte Valley
14 Metropolitan District (the "Overlap District"); and

15 **WHEREAS**, pursuant to C.R.S. § 32-1-107(3)(b)(IV), the Overlap District has
16 consented to the formation of the Coordination District and the provision of the same
17 services and facilities in any overlapping area; and

18 **WHEREAS**, pursuant to C.R.S. § 32-1-107(3)(b)(II), it is necessary that the City
19 Council adopt a resolution approving the inclusion of such overlapping services as part
20 of the service plan for the Coordination District; and

21 **NOW, THEREFORE,**
22 **BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

24 **Section 1.** Pursuant to C.R.S. § 32-1-107(3)(b)(II), the City Council hereby
25 approves the inclusion of overlapping services and facilities between the Central Platte
26 Valley Coordination Metropolitan District and the Central Platte Valley Metropolitan
27 District as part of the service plan for the Central Platte Valley Coordination
28 Metropolitan District.

29 **Section 2.** That the Clerk of the City and County of Denver shall attest and
30 affix the seal of the City and County of Denver to this Resolution.
