A RESOLUTION

5 **Approving and providing for the execution of a proposed Grant Agreement**
6 **between the City and County of Denver and the Colorado Department of Local**
7 **Affairs (DOLA) concerning the “Denver High School Microgrid for Community**
8 **Resilience (FFC)” program and the funding therefor.**

10 **WHEREAS**, the City and County of Denver has given due consideration to said proposed
11 Grant Agreement;

13 **NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY**
14 **OF DENVER:**

16 **Section 1.** The proposed Grant Agreement between the City and County of Denver and the
17 Colorado Department of Local Affairs for the “Denver High School Microgrid for Community
18 Resilience (FFC)” program, which is identified as Grant Number MCRF-FFC008, a copy of which is
19 duly filed with the City Clerk, Filing No. 202580133, be and hereby is approved in all respects.

20 **Section 2.** The payments made by the State of Colorado to the City pursuant to and under
21 the Grant Agreement shall be deposited into the Treasury of the City and credited to the Grant and
22 Other Money Project Funds Series (Accounting No. 38000), which is set forth and described in
23 Section 20-18 of the Revised Municipal Code of the City and County of Denver.

24 **Section 3.** That it be and is hereby found and determined that the budget summary of said
25 program, to be expended by the Executive Director of the Climate Action, Sustainability, and
26 Resiliency is as follows:
