9 **For an ordinance amending Ordinance No. 195, Series of 2005, to change the**  
10 **accounting numbers associated with the Crime Prevention and Control**  
11 **Commission (CPCC) and authorizing financial transactions necessary to**  
12 **transfer cash, budget balances and existing contracts from the Public Safety**  
13 **Special Revenue Fund to the Human Services Special Revenue Fund.**

16 **WHEREAS**, CB15-0917 has been submitted to move the CPCC from the Department of  
17 Public Safety to the Denver Department of Human Services, and changes code beginning  
18 D.M.R.C. Sec. 2-255.48 through Sec. 2-255.58; and

19 **WHEREAS**, the financial structure of Crime Prevention and Control Commission in the Public  
20 Safety Special Revenue Fund, Accounting No. 12000 will be transferred to the Human Services  
21 Special Revenue Fund, Accounting No. 13000 to accommodate this move; and

22 **WHEREAS**, all CPCC cash, budget balances and contracts will be transferred following the  
23 close of 2015 and includes 2016 amounts;

24 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF**  
25 **DENVER:**

26 **Section 1.** That portion of Section 2 of Ordinance No. 195, Series of 2005, is hereby  
27 amended to read as follows:

28 **“Section 2.**

29 (A) There is hereby established in the Human Services Special Revenue Fund, Accounting No.  
30 13000 (formerly 12000), a “Crime Prevention and Control Fund” Accounting Number 13821-  
31 5554000 (formerly 12821-3501000), for the purpose of supporting criminal justice planning  
32 activities and use of evidence-based programs and services to improve public safety.  
33

34 (B) Monies received from transfers from the General Fund as well as other contributions,  
35 donations, project incomes, interest earned, or other source of private receipts by the fund  
36 account described in subsection (A) of this Section 2 shall be deposited into the Treasury of  
37 the City and credited to Special Fund No. 13000 (formerly 12000) which is set forth and  
38 described in Section 20-18 of the Revised Municipal Code of the City and County of Denver,  
39 and specifically to the “Crime Prevention and Control Fund program, Accounting No. 13821-  
40 5554000 (formerly 12821-3501000).

1 (C) Expenditures are hereby authorized for the "Crime Prevention and Control Fund," program,  
2 Accounting No. 13821-5554000 (formerly 12821-3501000) in the amount not to exceed the  
3 total deposits described in subsection (B) of this Section 2, subject to review and  
4 recommendation by the Crime Prevention and Control Commission as required by section  
5 2-255.58, D.R.M.C.

7 (D) The Auditor and the Treasurer of the City and County of Denver are hereby authorized and  
8 directed to make such book and record entries and to do such other things as may be  
9 necessary to accomplish the purpose of this Ordinance."

11 **Section 2.** To hereby authorize the transfer of cash in the amount remaining at the close of  
12 2015 in addition to any 2016 amounts previously authorized for the CPCC program and any other  
13 financial transactions necessary to complete this move, including but not limited to the transfer of  
14 contracts and grants currently housed in the Department of Public Safety CPCC and the creation  
15 of new funds including the transfer of those related balances.

16 **Section 3.** The Chief Financial Officer of the City and County of Denver is hereby  
17 authorized and directed to make such book and record entries and to do such other things as may  
18 be necessary to accomplish the purposes of this Ordinance.
