This is the second three-way IGA between CCD, RTD, and COA for this Peoria Grade Separation Project. The first IGA, executed approximately a year ago, established the funding contributions of the three agencies to the overall project. This IGA covers many issues related to the project and funding, including:

- RTD will be responsible for funding and constructing the temporary at-grade crossing at Peoria St. as needed for the FasTracks East Corridor project until the Peoria Grade Separation is open. RTD will be reimbursed for this expense if there are funds remaining at the end of the Peoria project.
- New monies attracted to the Peoria project will go to completing the original scope of the project.
- There are mechanisms to reimburse the three agencies for expenses related to staff time (including outside professional services) to help administer parts of the project.
- Cost overruns, in excess of the current total budget of \$53 million, will be shared equally between CCD and RTD, offset by any financial contributions from COA. Currently, the project is projected to be under budget.
- After reimbursement of RTD for the at-grade crossing, and reimbursement to the three agencies for eligible staff time, RTD will be reimbursed for \$4.15 million should sufficient excess funds be available at the close of the project as set forth in an IGA between COA and RTD. If there are still excess funds after this, the three parties will share equally all remaining funds.
