### A. Mayor's Office - Anthony Aragon

- RR15-0577 Approves the Mayoral reappointments of Sabrina Coleman, Patrick Byrne, Tamika Gorman, Jessica Skibo, Courtney Smith, Lilly Berger, Corelle Spettigue, and Kara Veitch and the appointments of Nancy Reichman, Nicole Carter, Kimberly Ford, Serina Montoya, Miriam Pena, and Nicole Portee to the Denver Women's Commission for terms effective immediately and expiring 6-30-17, or until successors are duly appointed.
- RR15-0580 Approves the Mayoral youth appointments of Eric Webb, Cornelius Foxworth, Taylor Parrish, Edith Olivas-Ordonez, and Milah Thomas to the Advisory Commission on Youth for terms effective immediately and expiring on 8-31-18, or until successors are duly appointed.

## B. Community Planning and Development - Barbara Stocklin-Steely/ Tim Watkins

BR15-0585 Amends Chapter 30, Article 1, Sections 9 & 10, of the Denver Revised Municipal Code to provide correct references to state rules pertaining to landmark preservations and to reflect current review guidelines for historic rehabilitation tax credits.

# C. <u>Denver International Airport</u> - Amy Raaz

BR15-0579 Amends a lease agreement with Prospect International Airport Services, Inc. by adding \$48,344 in additional funds annually for a new annual total of \$58,610 to give Prospect additional office space at Denver International Airport to support their wheelchair service and assistance with wheelchair service to traveling passengers (201309825-02).

# D. <u>Human Services - Ron Mitchell</u>

BR15-0575 Amends a contract with Savio House Residential Child Care Facility to add a tiered rate structure for the vendor payment for a contract in the amount of \$844,225 to provide placements and case management services to children in out-of-home care. This amendment adds no additional dollars to the contract total (2015-21827-01).

## E. Office of Economic Development - Susaon Liehe/ Andrew Johnston

BR15-0571 Amends Chapter 27, Article III of the Revised Municipal Code (Preservation of Affordable Housing) to: 1) expand coverage to all affordable properties that have received any public assistance; 2) expand coverage to properties that are for sale; 3)provide the City or its designee a right of first refusal on for-sale units; and 4)increase the length of the required notice period.

- BR15-0570 Approves a Master Funding Agreement with Colorado Housing and Finance Authority (CHFA) paid out of the Revolving Affording Housing Loan Fund (RAHLF) for the administration, underwriting and servicing of the City's Revolving Affordable Housing Loan Fund (RAHLF). The costs will be covered by borrowers from the fund in the form of application and origination fees and a portion of the interest paid by borrowers.
- BR15-0584 Amends the "Metro Mortgage Assistance Plus Program" fund in the General Government Revenue Fund to allow for authorizing expenditures from the fund to be spent on additional affordable housing activities as approved jointly by the City's Director of OED and Chief Financial Officer.

### F. Office of Human Resources - Meredith Creme

BR15-0574 Amends the Classification and Pay Plan by changing multiple Finance & Accounting related pay grades and classification titles and establishes nine (9) new classifications and abolishes the classification of Accounting Technician.

## G. Public Works - Angela Casias

- RR15-0572 Grants a revocable permit to Tim Paynter to encroach into the right-of-way with an enclosed patio/building at 1130 South Federal Boulevard in Council District 7.
- RR15-0582 Dedicates land as West 27th Avenue at the intersection of West 27th Avenue and Vallejo Street in Council District 1.
- RR15-0583 Dedicates land as both Belleview Avenue and South Quebec Street at the intersection of Belleview Avenue and South Quebec Street in Council District 4.
