4 **A RESOLUTION**

5 **Laying out, opening and establishing as part of the City street system parcels of**  
6 **land as public alleys bounded by West 24th Avenue, North Clay Street, West 26th**  
7 **Avenue and North Eliot Street.**

8 **WHEREAS**, the Executive Director of Public Works of the City and County of Denver has  
9 found and determined that the public use, convenience and necessity require the laying out, opening  
10 and establishing as public alleys designated as part of the system of thoroughfares of the  
11 municipality those portions of real property hereinafter more particularly described, and, subject to  
12 approval by resolution has laid out, opened and established the same as public alleys;

13 **BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

14 **Section 1.** That the action of the Executive Director of Public Works in laying out, opening  
15 and establishing as part of the system of thoroughfares of the municipality the following described  
16 portions of real property situate, lying and being in the City and County of Denver, State of Colorado,  
17 to wit:

18 **PARCEL DESCRIPTION ROW NO. 2018-DEDICATION-0000225-001:**

19 Three parcels of land located in the NE¼ of Section 32, Range 3 South, Township 68 West of the  
20 6th Principal Meridian, City and County of Denver, Colorado, conveyed to the Town of Highland,  
21 County of Arapahoe, on March 6, 1882, annexed to the City of Denver, Arapahoe County, August  
22 25, 1896, and presently recorded in the records of the Clerk and Recorder of the City and County  
23 of Denver at Book 164, Page 312, more particularly described as follows:

25 The rear eight feet of each and every lot in blocks numbered twenty (20), twenty one (21), and twenty  
26 five (25), The Town of Highland, City and County of Denver and State of Colorado, said alleys being  
27 sixteen feet wide and running East and West through the center of said Blocks

28 be and the same is hereby approved and said real property is hereby laid out and established and  
29 declared laid out, opened and established as public alleys.

30 **Section 2.** That the real property described in Section 1 hereof shall henceforth be public  
31 alleys.
