**A BILL**

**For an ordinance making a rescission from a completed Capital Improvement Program, PO011, and making an appropriation in Capital Improvement Program, HY002, to support the development of micro communities for individuals experiencing homelessness.**

**WHEREAS**, the City wishes to rescind \$2,000,000 in savings from the completed Capital Improvement Program, RAMP: Federal Boulevard (6th to Howard); and

**WHEREAS**, said savings will be appropriated to the Micro Communities Implementation Capital Improvements Program to fund capital costs associated with the implementation of new micro communities in the City, including design and site work for new tiny home communities in the City and County of Denver;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** From appropriations heretofore made from the Capital Improvements and Capital Maintenance Fund Series, Accounting No. 31000, listed or indicated in the following tabulation there is hereby RESCINDED the amount listed or indicated in such tabulation under the heading "Amount Rescinded":
