**A BILL**

**For an ordinance making rescissions from the General Fund; making appropriations in the General Fund to make cash transfers; making appropriations in Special Revenue Funds and the Capital Improvement and Capital Maintenance Fund to address 2022 and 2023 needs; and authorizing the purchase of capital equipment.**

**WHEREAS**, the Denver Public Library, wishes to transfer 2022 savings to Capital Improvement and Maintenance Funds to address City Council’s request to fund the gap for modernization and deferred maintenance at Athmar Park, Barnum, Pauline Robinson, and Schlessman branches; and

**WHEREAS**, the Department of Housing Opportunity and Stability wishes to transfer 2022 savings to the Planned Fleet Special Revenue Fund to outfit outreach vans for the Early Intervention Team; and

**WHEREAS**, the Department of Housing Opportunity and Stability seeks approval to use budgeted savings for the purchase of three vans for unsheltered homelessness outreach; and

**WHEREAS**, the Office of the Municipal Public Defender wishes to reallocate 2022 General Fund operating budget to a technology Capital Improvement Fund for case management system modifications that were budgeted in 2022 but due to delays will not be completed this year;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** From appropriations heretofore made from the General Fund listed or indicated in the following tabulation there is hereby RESCINDED the amount listed or indicated in such tabulation under the heading "Amount Rescinded":
