6. **General description of proposed ordinance including contract scope of work if applicable:**

The scope of work will be for B2G to provide DBSO with a file format to facilitate the automated uploading and entering of Denver International Airport (DEN) revenue totals for concessions into B2G monthly. B2G will install the appropriate modules into the B2G application to facilitate the file upload, including providing access to a secure FTP site where the upload file will be delivered and received.

B2G will support DEN DSBO with the implementation of the new process, and will monitor the SFTP site. B2G will notify the DEN DSBO staff with the status of the monthly upload.

This automated process will eliminate revenue entry errors attributed to manual entry, including duplication of entries. The process will also eliminate the manual entry of all future revenues and increase accurate reporting. This implementation will only be used by DEN DSBO. (Not DSBO (downtown) or the Auditor).

- One time implementation cost is \$5,950.00
