5 **A BILL**

6 **For an ordinance making a rescission from General Fund Contingency and**  
7 **making appropriations to agency General Fund budgets, Special Revenue**  
8 **Funds, and authorizing cash transfers.**  
9

10 **WHEREAS**, the Department of Transportation and Infrastructure requests \$500,000 to  
11 support cost related increases to the cost of fuel, vehicle, and equipment parts; and

12 **WHEREAS**, the City Attorney’s Office requests \$500,000 to cover increases to personnel  
13 from pay equity audits and increases to outside legal counsel contracts; and

14 **WHEREAS**, the Denver District Attorney’s Office requests \$100,000 to cover increases to  
15 personnel from pay equity audits; and

16 **WHEREAS**, the Independent Monitor requests \$100,000 to cover increases to personnel  
17 from pay equity audits; and

18 **WHEREAS**, Denver Human Services requests \$1,244,000 to support personnel and  
19 services and supplies costs related to support for asylum seekers coming into Denver from outside  
20 of the US border; and

21 **WHEREAS**, the City’s Internal Billings and Reimbursements Special Revenue Fund  
22 requires a total increase of \$450,000 for increased Police personnel costs at the Airport due to  
23 overtime and collective bargaining increases, which will be offset by billings revenue;

25 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY**  
26 **OF DENVER:**

28 **Section 1.** From appropriations heretofore made from the General Fund listed or indicated in  
29 the following tabulation there is hereby RESCINDED the amount listed or indicated in such tabulation  
30 under the heading "Amount Rescinded" and transferred to the General Fund:
