A BILL

For an ordinance making a rescission from and an appropriation in the “Denver Public Library” Special Revenue Fund, to make a cash transfer to and appropriation in the “Library Capital” Fund.

WHEREAS, in the Denver General Election in November 2022, Denver voters approved Referred Measure 2I to increase the City’s mill levy rate by 1.5 mills starting January 1, 2023, to provide additional funding for the Denver Public Library (DPL) to maintain existing services and meet the increased demand for additional services; and

WHEREAS, per the approved Measure 2I the Denver Public Library receives property tax revenue to fund library services, per article XVIII of Chapter 53 of the DRMC; and

WHEREAS, Ordinance 1596, series of 2022, created the “Denver Public Library” Special Revenue Fund (15830) to receive the additional mill levy revenue and administer current and expanded services; and

WHEREAS, Ordinance 0136, series of 2023, created the “Library Capital” Fund (34041); and

WHEREAS, Resolution 1624, series of 2024 approved a purchase and sale agreement for property located at 1339 West Cedar Avenue in Denver; and

WHEREAS, the City wishes to reallocate funds from the “Denver Public Library Fund” to the “Library Capital Fund” to support the the design and implementation of a capital improvement project at said property;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. From appropriations heretofore made from the Denver Public Library Special Revenue Fund, Accounting No. 15830, listed or indicated in the following tabulation there is hereby RESCINDED the amount listed or indicated in such tabulation under the heading "Amount Rescinded":

1 **Section 2.** From the Denver Public Library Special Revenue Fund, Accounting No. 15830, out
 2 of monies rescinded from Section 1 not otherwise appropriated and in addition to amounts heretofore
 3 appropriated by Ordinance No. 1539, Series of 2024, and any supplemental appropriations or
 4 rescissions, there is hereby appropriated to the appropriation accounts hereinafter designated the
 5 amount of money following such designation, to be expended for the purposes and upon the
 6 authorizations in said Ordinance set forth:

7 The foregoing appropriation is to make a cash transfer to the Library Capital Fund to support the
 8 Bond supplemental for the Ross-Broadway, Schlessman, Ross-University Hills, and Eugene Fields
 9 Branch library; and to support deferred maintenance for HVAC and restroom renovations for the
 10 Schlessman, Ross-University Hills, and Eugene Fields Branch libraries.

 12 **Section 3.** From the Capital Improvement and Capital Maintenance Fund Series, Accounting
 13 No. 31000, out of monies transferred in Section 2 and not otherwise appropriated and in addition to
 14 amounts heretofore appropriated by Ordinance No. 1539, Series of 2024, and any supplemental
 15 appropriations or rescissions, there is hereby appropriated to the appropriation accounts hereinafter
 16 designated the amount of money, following such designation, to be expended for the purposes and
 17 upon the authorizations in said Ordinance set forth:
