8 **Approving and providing for the execution of a proposed amended Grant**  
9 **Agreement between the City and County of Denver and the Colorado**  
10 **Department of Public Health and Environment concerning the "Cancer,**  
11 **Cardiovascular and Pulmonary Disease" program and the funding therefor.**

14 **WHEREAS**, the City and County of Denver has given due consideration to said proposed  
15 amended Grant Agreement;

17 **NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY**  
18 **OF DENVER:**

20 **Section 1.** The proposed amended Grant Agreement between the State of Colorado,  
21 Department of Public Health and Environment, and the City and County of Denver, which is  
22 identified as Grant Number 2019\*0050 OL2, a copy of which is duly filed with the City Clerk, Filing  
23 No. 201841524-02, be and hereby is approved in all respects.

25 **Section 2.** The payments made by the Colorado Department of Public Health and  
26 Environment to the City pursuant to and under the amended Grant Agreement shall be deposited  
27 into the Treasury of the City and credited to Special Revenue Fund No. 14000, which is set forth  
28 and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.

30 **Section 3.** That it be and is hereby found and determined that the budget summary of said  
31 program, to be expended by the Executive Director of the Denver Department of Public Health and  
32 Environment is as follows:
