**A BILL**

**For an ordinance authorizing a capital equipment purchase from the Risk Management Fund (SRF 11838) Fund for Denver Parks and Recreation.**

**WHEREAS**, Denver Parks and Recreation (DPR) is seeking approval for a capital equipment purchase of eight vehicles to replace trucks that have been in accidents and have been classified as a total loss; and

**WHEREAS**, said vehicles are critical to DPR operations because they are used every day in their work at all locations; and

**WHEREAS**, said replacement vehicles have been approved by the Department of Finance (DOF), Risk Management Division to be purchased out of Special Revenue (11838); and

**WHEREAS**, capital equipment items with costs above the fifty-thousand-dollar threshold require City Council authorization;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** From the Risk Management Special Revenue Fund, Accounting No. 11838, the Chief Financial Officer, or duly authorized representatives, is hereby authorized to purchase or acquire the following capital equipment:

Truck	8

The foregoing vehicle purchase will support Denver Parks and Recreation operations.

3 to accomplish the purposes of this Ordinance.
