**Section 1.** That upon consideration of the Service Plan (and the conclusions contained therein) and other facts and information, the Service Plan for the Community Coordinating Metropolitan District, filed in the office of the Clerk and Recorder, Ex-Officio Clerk of the City and County of Denver, on the 24<sup>th</sup> day of November 2010, City Clerk's Filing No. 10-1168 shall be and the same is hereby approved.

Section 2. City Council hereby conditionally approves the proposed Service Plan subject to the following modification: On page 8, line 4, delete the words, "Fees and charges may be imposed within the Service Area of the Metro District and collected by the Metro District to the extent necessary to supplement other Metro District revenues; however; i" and insert "The District will have the authority to create the opportunity for pledged contributions that the District will rely on to fund construction, operation and maintenance and administrative costs and programming. The District shall not have the authority to establish mandatory fees. I" And on line 22 insert the word "and" after the phrase "from grants" and delete the words "and fees" and insert the sentence "The District will have the authority to create the opportunity for pledged contributions that the District will rely on to fund construction, operation and maintenance and administrative costs and programming. The District shall not have the authority to establish mandatory fees."
