6 **For an ordinance authorizing a capital equipment purchase in the American**
7 **Rescue Plan Act (ARPA) Grant Fund.**

9 **WHEREAS**, Ordinance No. 591, Series of 2021, established the, Fund No. 11011, and
10 accepted the Coronavirus Local Fiscal Recovery Fund award agreement with the US Department
11 of Treasury; and

12 **WHEREAS**, Ordinance No. 1192, Series of 2021, increased the “Revenue Loss” allocation
13 to authorize the 2022 portion of the 2021 “Revenue Loss” investments previously authorized
14 through Ordinance No. 706, Series of 2021; and

15 **WHEREAS**, Ordinance No.1192, Series of 2021, was intended to include a section to
16 authorize the purchase of a vehicle to support the Wellness Winnie Program; and

17 **WHEREAS**, this bill request authorizes the purchase of said vehicle, as a corrective action;
