**A BILL**

**For an ordinance establishing a "Social Impact Bond" fund in the General Government Special Revenue Fund and the means for authorizing expenditures from such fund.**

**BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** There is hereby established in the General Government Special Revenue Fund, Accounting No. 11000, a "Social Impact Bond " fund Program, Accounting No. 11863-2500000, for the purpose of restricting and accounting for the receipt of funds in accordance with statute, both for past and future contributions.

**Section 2.** Monies received from private, public or other sources of receipts shall be deposited into the Treasury of the City and credited to Special Fund No. 11000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.

**Section 3.** Expenditures are hereby authorized for the "Social Impact Bond" fund Program, Accounting No. 11863-2500000, in the amount not to exceed the total of deposits described in Section 2 of this Ordinance, to be expended by the Manager of Finance. Authorized expenditures will include, but shall not be limited to performance-based payments to contractors providing housing and case management for chronically homeless individuals.

1       **Section 4.** The Manager of Finance of the City and County of Denver is hereby authorized  
2 and directed to make such book and record entries and to do such other things as may be  
3 necessary to accomplish the purposes of this Ordinance.
