A RESOLUTION

5 **Approving and providing for the execution of a proposed Grant Agreement**
6 **between the City and County of Denver and the State of Colorado Regional**
7 **Transportation District (RTD) concerning the “RTD – DRCOG Surface**
8 **Transportation Block Grant Central Corridor Vision and Alternatives**
9 **Analysis” program and the funding therefor.**

11 **WHEREAS**, the City and County of Denver has given due consideration to said proposed
12 Grant Agreement;

14 **NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY**
15 **OF DENVER:**

17 **Section 1.** The proposed Grant Agreement, under CFDA No. 20-500, between the City and
18 County of Denver and the State of Colorado Regional Transportation District (RTD), for the “RTD –
19 DRCOG Surface Transportation Block Grant Central Corridor Vision and Alternatives Analysis”
20 program, which is identified as Grant Number 1136-2026-1, a copy of which is duly filed with the City
21 Clerk, Filing No. 202683170, be and hereby is approved in all respects.

22 **Section 2.** The payments made by the State of Colorado RTD to the City pursuant to and
23 under the Grant Agreements shall be deposited into the Treasury of the City and credited to Special
24 Revenue Fund No. 38000, which is set forth and described in Section 20-18 of the Revised Municipal
25 Code of the City and County of Denver.

26 **Section 3.** That it be and is hereby found and determined that the budget summary of said
27 program, to be expended by the Executive Director of the Department of Transportation and
28 Infrastructure, is as follows:
