Approves a contract with Jewish Family Service of Colorado Inc, doing business as SHALOM Denver for Program Year 2015-16, in the amount of \$650,000, for the purpose of assisting in fulfilling Temporary Assistance for Needy Families (TANF) work participation requirements that lead to unsubsidized employment services for TANF recipients (OEDEV- 201523737-00). Amends the Denver Revised Municipal Code to lower the actuarially assumed rate of investment return to 7.75% from the current rate of 8.0%, and to remove obsolete language or clarify Code language intent. The Committee approved filing this bill at its meeting on 8-25-15.

CB15-0624 A bill for an ordinance amending the classification and pay plan for employees in the Career Service and for certain employees not in the Career Service.

Approves classification notice #1507 by amending the Classification and Pay Plan by adding Document Management Technician, pay grade 612-C. The Committee approved filing this bill by consent on 9-3-15.

#### **Infrastructure & Culture**

CB15-0548 A bill for an ordinance approving a proposed Sponsorship Agreement between the City and County of Denver, The Superlative Group, Inc., and MillerCoors, LLC to obtain certain sponsorship opportunities in connection with the City venues.

Approves a three-year sponsorship revenue agreement for \$375,000 annually with MillerCoors, LLC (totaling \$1,125,000 over the contract term through 12-31-17) for marketing and advertising assets in City Venues (201520449).
