

**SIXTH AMENDATORY AGREEMENT**

This **SIXTH AMENDATORY AGREEMENT** is made and entered into by and between the **CITY AND COUNTY OF DENVER**, a municipal corporation of the State of Colorado (the “City”), and **TYLER TECHNOLOGIES, INC.**, a Delaware corporation having its principal place of business at 5519 53<sup>rd</sup> Street, Lubbock, Texas 79414 (the “Vendor”) collectively referred to as the “Parties.”

**WITNESSETH:**

**WHEREAS**, the Parties entered into an Agreement dated June 12, 2007, and amended on April 22, 2008, October 30, 2009, December 27, 2011, December 17, 2012, and December 23, 2013 (the “Agreement”), to provide annual software maintenance on the City’s CAMA and OASIS systems (the “Agreement”); and

**WHEREAS**, the Parties wish to amend the Agreement to extend the term and increase the compensation to the Vendor and to incorporate the Time and Materials pricing set out on the attached quote.

**NOW, THEREFORE**, in consideration of the premises and the mutual covenants and obligations herein set forth, the Parties agree as follows:

1. The attached quote is hereby incorporated herein and replaces any previously incorporated quotes for services.

2. Article 2 of the Agreement entitled “TERM” is amended to read as follows:

“2. **TERM:** The term of the Agreement is from January 1, 2007 to and through December 31, 2018.”

3. Article 3(D)(i) of the Agreement entitled “Maximum Contract Liability” is hereby amended to read as follows:

“3. **COMPENSATION AND PAYMENT:**

**D. Maximum Contract Liability:**

(i) Any other provision of this Agreement notwithstanding, in no event shall the City be liable for payment for services rendered and expenses incurred by the Vendor under the terms of this Agreement for any amount in excess of the sum of **TWO MILLION EIGHTY-EIGHT THOUSAND FIVE HUNDRED THREE DOLLARS AND TWENTY CENTS (\$2,088,503.20)**. The Vendor acknowledges that any work performed by Vendor beyond that specifically authorized by the City is performed at Vendor’s risk without authorization under this Agreement.”

4. Except as herein amended, the Agreement is affirmed and ratified in each and every particular.

The on-site rates reflect the cost of the travel time to and from the client's site. Travel and other out-of-pocket expenses will be billed at direct cost. The above rates are subject to change periodically, reflecting changes in labor costs, taxes, etc. The Company will notify the Client of said changes in writing.

If Tyler staffing requirements are such that services must be provided using contract labor, whose cost basis is significantly above what is built into Tyler's Time and Materials rates, the T&M hourly rates for off-site work performed at Tyler offices on behalf of the Client for said contractor will be computed to reflect the Company's cost plus 25%; the on-site rates for work performed at the Client site will be this cost plus a 50% premium. The Company will notify the Client in advance when responding to a request using contract labor whose cost will exceed the above fee schedule.
