CB15-0087 A bill for an ordinance approving a proposed Master Purchase Order between the City and County of Denver and Revolution Foods, Inc., for the Snacks and Supper Food Service Program.

CB15-0091 A bill for an ordinance approving the National Western Center Master Plan, which plan shall become a part of the Comprehensive Plan for the City and County of Denver pursuant to the provisions of Section 12-61 of the Denver Revised Municipal Code.

Adopts the National Western Center Master Plan as part of the City's Comprehensive Plan. The Committee approved filing this bill at its meeting on 2-18-15

CB15-0009 A bill for an ordinance approving a proposed Loan Agreement between the City and County of Denver and 48Race, LLC, for a land

acquisition loan for 4800 Race Street and 4800 Vine Street.

Grants a 10-year loan in the amount of \$1.5 million to 48Race, LLC (real estate holding company of the Urban Land Conservancy) for acquisition of 4800 Race Street and 4800 Vine Street in Council District 9. The last regularly scheduled Council meeting within the 30-day review period is on 3-23-15. The Committee approved filing this bill at its meeting on 1-6-15.

CB15-0078 A bill for an ordinance approving a proposed First Amendment to Airport Use and Lease Agreement between the City and County of Denver and GoJet Airlines LLC related to leased space at Denver International Airport.

Amends a lease agreement with GoJet Airlines Airport to add an additional 932.7 square feet of leased space on Concourse B at Denver International Airport and adding approximately \$150,200 in annual revenue (201206560-01). The last regularly scheduled Council meeting within the 30-day review period is on 3-23-15. The Committee approved filing this bill by consent on 2-19-15.

CB15-0086 A bill for an ordinance approving a proposed Agreement between the City and County of Denver and The Denver Urban Renewal Authority to administer a single family rehabilitation program.

Approves a \$500,000 contract through 5-31-16 with Denver Urban Renewal Authority (DURA) to help improve permanent residential owner-occupied housing in Denver through the Single Family Rehabilitation (SFR) program (OEDEV-201419658). The last regularly scheduled Council meeting within the 30-day review period is on 3-23-15. The Committee approved filing this bill by consent on 2-19-15.

CB15-0096 A bill for an ordinance approving a proposed Agreement between the City and County of Denver and Intermountain Electric Inc. concerning preventive maintenance of electric power switchgears at Denver International Airport.

Approves an agreement with Intermountain Electric, Inc. for \$850,000 through 3-1-19 for testing and preventive maintenance of the electric power switchgears and related equipment at Denver International Airport (201416821). The last regularly scheduled Council meeting within the 30-day review period is on 3-23-15. The Committee approved filing this bill by consent on 2-19-15.

Infrastructure & Culture

CB15-0020 A bill for an ordinance approving a proposed Intergovernmental Agreement between the City and County of Denver and the Regional Transportation District (RTD), relating to the 16th Street Mall Intersection Improvements and the funding therefor.

Approves an intergovernmental agreement with the Regional Transportation District for intersection reconstruction costs totaling \$1,845,149 for concrete intersections and traffic signals of five intersections on the 16th Street Mall. The last regularly scheduled Council meeting within the 30-day review date is on 3-23-15. The

Committee approved filing this bill by consent on 1-14-15.

CB15-0062 A bill for an ordinance approving a proposed Third Amendatory Design Service Agreement between the City and County of Denver and Wilson & Company, Inc., Engineers & Architects, for additional design services for the 33rd Street Outfall Project at 31st and 36th Streets.

Adds \$883,587 (for a new total of \$2,296,363.45) to the contract with Wilson & Company, Inc. for additional design services, construction related services, land acquisition services, and site investigation on the 33rd Street Outfall Project (31st and 36th Street Outfall Project) in Council Districts 8 & 9 (201101768). The last regularly scheduled Council meeting within the 30-day review period is on 3-23-15. The Committee approved filing this bill by consent on 2-12-15.

Safety & Well-being

CB15-0012 A bill for an ordinance approving a proposed Amendatory Agreement between the City and County of Denver and Denver Health and Hospital Authority dba Denver Health Medical Center to provide treatment services to chronically homeless individuals.

Amends a contract with Denver Health & Hospitals Authority to provide housing and treatment services to the homeless and provide transitional residential treatment, case management, and or mental health services up to 100 chronically homeless individuals who have a history of detoxification use in Denver. Denver Human Services is requesting to increase the budget to \$699,995.50 and to extend the term for funding year 2015. The last regularly scheduled Council meeting within the 30-day review period is on 3-23-15. The Committee approved filing this bill by consent on 1-8-15.

CB15-0047 A bill for an ordinance approving a proposed Revival and Third Amendatory Agreement between the City and County of Denver and Urban Peak Denver to provide housing and services for homeless youth who have aged out of foster care.

Amends an agreement with Urban Peak Denver to add an additional \$256,280 (for a new total dollar amount of \$768,840) to provide six housing units for the youth ages 16 to 22 enrolled in the Rocky Mountain Youth Housing program (SOCSV201309749-03). The last regularly scheduled Council meeting within the 30-day review period is on 3-23-15. The Committee approved filing this bill by consent on 2-5-15.

CB15-0097 A bill for an ordinance approving and providing for the execution of a proposed amendment to the Grant Agreement between the City and County of Denver and the United States of America, concerning the "FEMA Public Assistance" program and the funding therefor.

Amends an existing grant from the Federal Emergency Management Agency (FEMA) to add the remaining four projects to the contract for an additional amount of \$2,362,256.95 so that the City may be reimbursed for the 75% federal and 12.5% state shares of the eligible FEMA expenditures incurred for flood recovery (MOOEM-

201417809-00). The last regularly scheduled Council meeting within the 30-day review period is on 3-23-15. The Committee approved filing this bill by consent on 2-19-15.

Announcement

On Monday, March 16, 2015, there will be a one-hour courtesy public hearing on CB15-0083, granting Qwest Broadband Services, doing business as CenturyLink, a non-exclusive franchise agreement with a duration of 10 years and authorization to make reasonable and lawful use of the public right-of-way within the City to construct, operate, maintain, reconstruct and rebuild a cable system for the purpose of providing cable television service in exchange for 5% of gross revenues.

And, dependent upon publication on Tuesday, March 31, 2015, there will be a required public hearing on CB15-0056, changing the zoning classification for 195 S. Monaco Parkway.
