13 WHEREAS, the United States Department of Transportation-Federal Transit Administration  
14 (USDOT-FTA) has tendered to the City a grant of \$1,155,872 as part of the competitive Tiger II  
15 Planning Grant Program", a copy of which is duly filed with the City Clerk, Filing No. 11-089; and

16 WHEREAS, the United States Department of Housing and Urban Development (USHUD)  
17 has tendered to the City a grant of \$1,797,500 for the as part of the competitive Community  
18 Challenge Planning Grant Program", a copy of which is duly filed with the City Clerk, Filing No.  
19 11-088; and

20 WHEREAS, said grants together will fund projects within the City of Denver Community  
21 Challenge Planning Grant Program – "Denver TOD Strategic Implementation Program", per the  
22 proposed Conditional and Preliminary Joint DOT-HUD Term Sheet for Planning Grants, a copy  
23 of which is duly filed with the City Clerk, Filing No. 11-087; and
