COMMITTEE OF REFERENCE:

A BILL

For an ordinance amending Ordinance No. 42, Series of 2008, concerning the "Secure Our Schools" Program.

BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. That portion of Section 5 of Ordinance No. 42, Series of 2008, now reading:

“Section 5. That it be and is hereby found and determined that the budget summary of said "Secure Our Schools" Program, Auditor's No. 12220-3518101-S1090, is as follows, to be expended by the Manager of Safety:

Federal Government	\$200,250
Match from Target Corporation	<u>100,250</u>
Total	\$300,500

Authorization for expenditure of said funds following execution of said grant will cover the period from September 1, 2007 to August 31, 2009.

A match in the amount of \$200,250 is required by the Grant, of which **\$100,000** will be provided by the Property Confiscation Fund, Accounting No. 12010-0405101 and **\$100,250** from the Target Corporation.”

11 be provided by the Property Confiscation Fund, Accounting No. 12010-0405101 and
12 **\$100,000** from the Target Corporation."

14 Section 2. The Manager of Finance of the City and County of Denver is hereby authorized
15 and directed to make such book and record entries and to do such other things as may be
16 necessary to accomplish the purposes of this Ordinance.
