
We support the adoption of this amendment as the next step in making the National Western Center vision a reality and thank you for your time and consideration.

Over the course of their storied 109 year history, the National Western Stock Show has been an important driver of economic and business growth in Colorado around the agricultural industry, and with the new and highly anticipated National Western Center, that growth will continue for years to come. The boldness of the plan builds on the state's already strong agricultural roots and positions Colorado as a global player in agricultural business, science and tourism. We are thrilled to stand in support of the rezoning application for the National Western Center.

Fueled by the master planning process in conjunction with the National Western's MOU Partners and the community-focused Advisory Committee, a variety of diverse stakeholders have contributed to the new program and site design elements of the National Western Center Campus. These community interests include agriculture and science educational opportunities, open space, access to the South Platte River and a new arena to replace the aging Coliseum.
