5 **A BILL**

6 **For an ordinance establishing a new fund in the General Government Special**  
7 **Revenue Fund Series for the “Human Rights and Community Partnerships**  
8 **Collaboration” program, rescinding budget, making an appropriation and a**  
9 **making a cash transfer from the Human Services Special Revenue Fund**  
10 **Series.**  
11

12 **WHEREAS**, there is a need for a Special Revenue Fund to facilitate financial support for  
13 collaborative projects between Human Rights and Community Partnerships and other City  
14 agencies; and  
15

16 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY**  
17 **OF DENVER:**  
18

19 **Section 1.** A new fund is hereby established in the General Government Special Revenue Fund  
20 Series, Accounting No. 11000, a “Human Rights and Community Partnerships Collaboration” Fund,  
21 Accounting No. 11875, for the purpose of accounting for the receipt and expenditure of program  
22 dollars.

23 **Section 2.** Monies received from transfers from other City funds for Accounting No. 11875 shall  
24 be deposited into the Treasury of the City and credited to Special Revenue Fund No. 11000, which  
25 is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of  
26 Denver.

27 **Section 3.** Program expenditures are hereby authorized for the “Human Rights and Community  
28 Partnerships Collaboration” Fund, Accounting No. 11875, in the amount not to exceed the total of  
29 deposits described in Section 2 of this ordinance to be expended by the Director of the Human Rights  
30 and Community Partnerships. Allowable expenditures include those for programs and services that  
31 are tied to shared initiatives between HRCP and other City agencies. The Chief Financial Officer  
32 may transfer unused balances in the Fund to the General Fund. This Fund is revenue-based and  
33 non-lapsing.

1 **Section 4.** From appropriations heretofore made from the Human Services Special Revenue  
 2 Fund listed or indicated in the following tabulation there is hereby RESCINDED the amount listed or  
 3 indicated in such tabulation under the heading "Amount Rescinded" and transferred to the Human  
 4 Services Special Revenue Fund:

5 **Section 5.** From the DHS Affordability Program Fund, Accounting No. 13813, out of monies  
 6 rescinded from Section 4 not otherwise appropriated and in addition to amounts heretofore  
 7 appropriated by Ordinance No. 1280, Series of 2018, and any supplemental appropriations or  
 8 rescissions, there is hereby appropriated to the appropriation accounts hereinafter designated the  
 9 amount of money following such designation, to be expended for the purposes and upon the  
 10 authorizations in said Ordinance set forth:

 13 The foregoing is to appropriate funds to make a transfer of cash to the Human Rights and  
 14 Community Partnerships Collaboration Fund to support financial coaching efforts.

 16 and directed to make such book and record entries and to do such other things as may be necessary  
 17 to accomplish the purposes of this Ordinance.
