Dear Council President Brooks:

In keeping with the provisions of Section 20-93 of the Denver Revised Municipal Code (the "DRMC"), I am hereby notifying you of the Department of Finance's intent to issue Special Facilities (United Airlines Project) Airport Refunding Bonds, Series 2017 (the "Bonds"), for an on behalf of the Department of Aviation, in an amount not to exceed \$280 million for the of purpose of refunding Special Facilities Airport Series 2007 bonds. The 2017 Special Facilities Bonds will be issued as fixed rate obligations with a final maturity of 2032.

The City has by ordinance designated the Department of Aviation as an Enterprise within the meaning of the TABOR Amendment to the Colorado State Constitution. Special Facilities Bonds are special obligations of the City, for and on behalf of the Department of Aviation, payable solely from a pledge on lease payments United Airlines makes on leased facilities at the Airport. Neither the full faith and credit, nor the taxing power of the City, will be pledged in payment of the Bonds.

In keeping with the intent of 20-93(b) of the DRMC, the President of Council will be notified promptly of any material change. The accompanying *Attachment A* contains a more detailed description of the financing. I do not anticipate formally communicating technical changes in the financing.

**DESCRIPTION OF THE AIRPORT SYSTEM
SPECIAL FACILITIES (UNITED AIRLINES PROJECT) AIRPORT REFUNDING BONDS, SERIES 2017**

I. The Proposed Financing

The City and County of Denver, for an on behalf of its Department of Aviation, is issuing Special Facilities Airport Refunding Series 2017 Bonds (the “Bonds”) for the purpose of refunding special facilities series 2007 bonds to achieve interest cost savings for the benefit of United Airlines. The 2007 bonds refunded bonds originally issued in 1992, which funded certain aircraft maintenance, ground equipment support facility, air freight facility and flight kitchen improvements located on land leased by United Airlines (the “United Airlines Project”). The Bonds will be issued in a fixed rate mode in an amount not to exceed \$280 million, at an interest rate not to exceed 6.0%. As of August 2017, savings are estimated to be in excess of \$28 million or 10% present value savings. The final par amount and interest rate will be fixed upon pricing of the transaction. The final maturity date on the Bonds, 2032, will not exceed the original term of the 2007 bonds being refunded.

II. Security for the Bonds

The City has by ordinance designated the Department of Aviation as an Enterprise within the meaning of the TABOR Amendment to the Colorado State Constitution. The City will be issuing the Series 2017 Bonds on behalf of its Department of Aviation as Special Facilities Bonds, which are permissible under the Airports General Bond Ordinance. The 2017 Special Facilities Airport Refunding Bonds are payable solely from and secured by the lease payments United Airlines makes on leased facilities at the Airport as part of the United Airlines Project, via an Amended and Restated Special Facilities and Ground Lease. None of the properties of the Airport System are subject to any mortgage or other lien for the benefit of the owners of the Bonds. No funds of the City or the Airport secure the Bonds and the Bonds are not considered debt of the City or the Airport. Neither the full faith and credit, nor the taxing power of the City, will be pledged in payment of the Bonds.

III. The Sale Process

The Series 2017 Bonds will be sold in a negotiated process with Citigroup serving as senior underwriter and Barclays, BBVA Compass and Siebert Cisneros Shank & Co serving as co-managers on the Bonds. The Underwriting team was appointed at the sole direction of United Airlines, given the Bonds do not constitute debt of the City or the Airport. The City uses the financial advisory services of Frasca & Associates LLC for Airport financings.
