The ordinance approves a grant agreement amendment with Denver Neighborhood Revitalization, Inc. (DNRI) to revise the provisions related to the Applicant Verification Statute and revise the date to return program revenue. House Bill 1023 may conflict with the federal eligibility and verification requirements in Title VI of the Personal Responsibility and Work Opportunity Reconciliation Act of 1966 (Welfare Reform Act), 8 U.S.C 1601-1646. Federal law rather than the state law will apply to the extent there is a conflict between House Bill 1023 and the Welfare Reform Act with regard to activities covered by the Welfare Reform Act.
