9 **For an ordinance amending Ordinance No. 358, Series of 2002, concerning the**
10 **“Environmental Health Donations” fund in the Health Special Revenue Fund.**

12 **Whereas**, the Department of Environmental Health has a donations special revenue fund,
13 established in 2002, for donations to the agency; and

14 **Whereas**, the fund has been primarily used as the Animal Care and Control donations fund;
15 and

16 **Whereas**, Animal Care and Control was bequeathed a gift as part of an estate that specifies
17 the use of the funds for Animal Care and Control use only, and necessitates narrowing the
18 purpose of the fund for Animal Care and Control use only;

20 **BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

22 **Section 1.** That portion of Section 1 of Ordinance No. 358, Series of 2002, now reading:
23 ““Environmental Health Donations” fund, Auditor’s No. 14702-6501000, for the purpose of
24 accepting private donations for environmental health purposes” is hereby amended to read as
25 follows: ““Animal Care and Control Donations” fund, Auditor’s No. 14702-6501000, for the purpose
26 of accepting private donations for Animal Care and Control purposes.”

28 **Section 2.** That portion of Section 3 of Ordinance No. 358, Series of 2002, now reading
29 “Environmental Health Donations” is hereby amended to read as follows: “Animal Care and
30 Control Donations”.

1 **Section 3.** The Manager of Finance of the City and County of Denver is hereby authorized
2 and directed to make such book and record entries and to do such other things as may be
3 necessary to accomplish the purposes of this Ordinance.
