**6. General description of proposed ordinance including contract scope of work if applicable:**

This ordinance will approve a contract amendment with The Western Stock Show Association to extend the term to 5/31/2020 or until either party terminates.

The City currently leases a parcel of land located approximately at the intersection of north Brighton Blvd. and Interstate 70 in the City and County of Denver from the Colorado Department of Transportation. The City uses the City Parcel for parking purposes for events which take place at the nearby Denver Coliseum; and the City contracts with a 3<sup>rd</sup> party company to administer parking operations for the City parcel. The Western Stock Show Association owns a parcel of land which is surrounded on three sides by the City Parcel and is also used for parking purposes. It is of mutual benefit and interest of both parties to combine the two separate parking operations in a single parking operation and share the revenue.
