FOR AN ORDINANCE VACATING A CERTAIN PART
OF THE SYSTEM OF THOROUGHFARES OF THE SYSTEM
OF THOROUGHFARES OF THE MUNICIPALITY; I.E.,
VACATING OF ALLEY IN BLOCK 1, SYLVESTER'S
ADDITION TO VANDERBILT PARK, BLOCK IS
BOUNDED BY SOUTH CHEROKEE STREET, WEST OHIO
AVENUE, VACATED SOUTH ELATI STREET AND VALLEY
HIGHWAY, SUBJECT TO CERTAIN RESERVATIONS.

WHEREAS, the Manager of Public Works of the City and County
of Denver has found and determined that the public use, convenience
and necessity no longer require that certain alley in the system of
thoroughfares of the municipality hereinafter described and, subject
to approval by ordinance, has vacated the same with the reservations
hereinafter set forth; now, therefore,

BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. That the action of the Manager of Public Works
in vacating the following described alley in the City and County
of Denver and State of Colorado, to wit:

That part of the alley in Block 1, Sylvester's Addition
to Vanderbilt Park, lying between the north line of
Lot 8, said Block 1, extended easterly, said north line
also being the southerly right-of-way line of the Valley
Highway and the south line of said Block 1.

be and the same is hereby approved and the described alley is
hereby vacated and declared vacated, provided, however, said
vacation shall be subject to the following conditions and
reservations:

That easements be and are hereby retained to
protect the utilities in the vacated alley
which utilities include Mountain Bell telephone
lines and Public Service Company power lines.
