A B I L L

FOR AN ORDINANCE VACATING CERTAIN PARTS OF THE SYSTEM OF THOROUGHFARES OF THE MUNICIPALITY; i.e., VACATING ALLEYS IN BLOCKS 1, 2, 3, 66, 67, 74, 75, 76, 77, 100, 241, 242 AND 255, WEST DENVER; ALSO, ALLEYS IN W.W. AND I.B. PORTER'S RESUBDIVISION OF LOTS 3, 4, 5 AND 6, BLOCK 100, WEST DENVER, SUBJECT TO CERTAIN RESERVATIONS.

WHEREAS, the Manager of Public Works of the City and County of Denver has found and determined that the public use, convenience and necessity no longer require those certain alleys in the system of thoroughfares of the municipality hereinafter described and, subject to approval by ordinance, has vacated the same with the reservations hereinafter set forth; now, therefore, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. That the action of the Manager of Public Works in vacating the following described alleys in the City and County of Denver and State of Colorado, to-wit:

The alleys in Blocks 1, 2, 3, 66, 67, 74, 75, 76, 77, 100, 241, 242 and 255, West Denver.

Also

The alleys in W.W. and I.B. Porter's Resubdivision of Lots 3, 4, 5 and 6, Block 100, West Denver.

be and the same is hereby approved and the described alleys are hereby vacated and declared vacated, provided, however, said vacation shall be subject to the following conditions and reservations:

1. Easements are retained for telephone lines in the alleys in Blocks 241 and 242, West Denver.
2. Easement for a gas line in the alley in Block 241, West Denver.
3. Easements for sanitary sewer lines in the alleys in Blocks 1, 2, 3, 66, 67, 75, 76, 77, 100 and 242, West Denver, and the alleys in W.W. and I.B. Porter's Re-subdivision of Lots 3, 4, 5 and 6, Block 100, West Denver.

Section 2. The Council finds this Ordinance is necessary for the immediate preservation of the public health and public safety, and determines that it shall take effect immediately upon its final passage and publication.

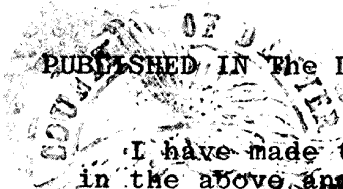
