9 For an ordinance submitting to a vote of the qualified and registered electors of the  
10 City and County of Denver at a special municipal election to be held in conjunction with  
11 the state general election of November 8, 2016, a proposed amendment to the Charter  
12 of the City and County of Denver concerning the Office of the Independent Monitor  
13

14 **BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

15  
16 **Section 1.** There is hereby submitted to the properly qualified and registered electors of  
17 the City and County of Denver for their approval or rejection at a special municipal election to be  
18 conducted at the same time and in conjunction with the state general election to be held in the  
19 City and County of Denver on November 8, 2016, a proposed amendment to the Charter of the  
20 City and County of Denver, as follows:

21  
22 **Effective upon publication and filing with the Secretary of State pursuant to the**  
23 **Constitution and laws of the State of Colorado, the following sections of the 2002**  
24 **Charter of the City and County of Denver shall be and are hereby amended to read**  
25 **as follows:**

27 Amend Part 6 of Article II by adding a new Section 2.6.7, to read as follows:

28 **§ 2.6.7 Office of Independent Monitor**

29 (A) *Office created.*

31 (i) There is hereby created the office of the independent monitor  
32 (“monitor’s office”) for the City and County of Denver. This office shall  
33 consist of a full-time monitor with appropriate professional and support  
34 staff. For purposes of this section, “monitor” means the head of the  
35 office of the independent monitor.  
36

- 1 (ii) The monitor's office shall actively monitor and participate in any  
2 investigations as may be prescribed in ordinance of uniformed  
3 personnel; make recommendations to the manager of safety regarding  
4 administrative action, including possible discipline, for such uniformed  
5 personnel; make recommendations regarding policy issues; and  
6 address any other issues of concern to the community, the members of  
7 the citizen oversight board ("board") created pursuant to subsection (B)  
8 of this section, the manager of safety, the chief of police, or the sheriff.  
9 For purposes of this article, "uniformed personnel" means all members  
10 of the classified service of the Denver police department, all sworn  
11 members of the Denver sheriff department, and members of the Denver  
12 fire department who are authorized to carry and use firearms on duty.  
13
- 14 (iii) The monitor shall establish standards of professional conduct and a  
15 comprehensive training program for its own staff in order to evaluate  
16 whether internal investigations have been properly conducted and to  
17 make recommendations as to the sustaining of rule violations, the  
18 imposition of disciplinary sanctions, and changes in policy and training.  
19
- 20 (iv) The monitor shall exercise such other powers and duties as may be  
21 provided by ordinance.  
22

23 (B) *The citizen oversight board.* There is hereby created the citizen oversight board,  
24 the size, qualifications, composition and appointment of which shall be as provided  
25 by ordinance. The functions of the board shall be to:

- 27 (i) Assess the effectiveness of the monitor's office;
- 28
- 29 (ii) Make policy-level recommendations regarding discipline, use of force,  
30 and other policies; rules; hiring; training; community relations; and the  
31 complaint process;
- 32
- 33 (iii) Address any other issues of concern to the community, members of the  
34 board, the monitor, the manager of safety, the chief of police, the  
35 sheriff, or the fire chief;
- 36
- 37 (iv) Make recommendations as to specific cases as may be prescribed in  
38 ordinance; and
- 39
- 40 (v) Exercise such other powers and duties as may be provided by  
41 ordinance.

**Section 2.** The voting machines and paper ballot for said election shall carry the following designation, which shall be the title and submission clause:

**REFERRED QUESTION \_\_\_\_\_**

Shall the Charter of the City and County of Denver be amended concerning the office of independent monitor and the citizen oversight board, as previously created by ordinance, for the purposes of monitoring investigations of uniformed personnel in the Denver Department of Safety, in order to formalize the existence of the monitor and the board in the charter, and to adopt in the charter the basic powers and duties of the monitor and the board?

**Section 3.** Each elector voting at the election and wishing to vote for or against the amendment shall indicate the elector’s choice by depressing the appropriate counter of the voting machine which indicates the word “YES” or the word “NO”, or by appropriate marking upon paper ballots when used.

**Section 4.** The proper officials of the City and County of Denver as are charged with duties relating to the election shall, before the election, issue such calls, make such certifications and publications, give such notices, make such appointments, and do all such other acts and things in connection with the submission of this Charter amendment to the registered electors of the City and County of Denver at the election as are required by the Constitution and laws of the State of Colorado and the Charter and ordinances of the City and County of Denver.

**Section 5.** The ballots cast at such election shall be canvassed and the results ascertained, determined, and certified in accordance with the requirements of the Constitution and laws of the State of Colorado and the Charter and ordinances of the City and County of Denver.

**Section 6.** If any section, paragraph, clause, or other portion of this ordinance is held to be invalid or unenforceable for any reason, the validity of the remaining portions of this ordinance shall not be affected.

**Section 7.** If approved by the voters, the Charter amendments set forth herein shall be effective January 1, 2017.
