A BILL

For an ordinance making a rescission from and an appropriation in the General Fund.

9 **WHEREAS**, City Council approved the long-term rental licensing program on May 3rd, 2021
10 through Ordinance No. 420, Series of 2021; and

11 **WHEREAS**, the new program will incur unbudgeted costs in the Department of Excise and
12 Licenses including technology, community outreach, and position costs for program administration;


