10 **For an ordinance amending Ordinance No. 134, Series of 2012,**
11 **concerning the “Public Works Alternative Fuel Vehicles Donation”**
12 **Special Revenue Fund**

14 **WHEREAS**, Ordinance 134, Series 2012 established the Public Works Alternative
15 Fuel Vehicles Donation Special Revenue Fund and the means for authorizing
16 expenditures from said fund; and

17 **WHEREAS**, said expenditures were not to be approved until after the City had
18 selected a vendor for the construction of a Compressed Natural Gas (CNG) fueling
19 station; and

20 **WHEREAS**, the Department of Public Works has completed the request for
21 qualifications to identify the vendors who could compete for the construction of a CNG
22 fueling station; and

23 **WHEREAS**, the Department of Public Works would like to order the CNG vehicles
24 due to the lengthy process to purchase and receive a vehicle;

25 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND**
26 **COUNTY OF DENVER:**

27 **Section 1.** That Section 3 of Ordinance No. 134, Series of 2012, is hereby
28 amended to read as follows:

29 “Section 3. Expenditures from the “Public Works Alternative Fuel Vehicles
30 Donations” fund, Accounting No. 11606-5011101, shall not exceed the total of
31 deposits described in Section 2 of this Ordinance. Authorized expenditures may
32 include the incremental cost of purchasing CNG vehicles over traditional fuel
33 vehicles and other incidental costs associated with the alternative fuel vehicle
34 program.”

1 **Section 2.** The Manager of Finance of the City and County of Denver is hereby
2 authorized and directed to make such book and record entries and to do such other
3 things as may be necessary to accomplish the purposes of this Ordinance.
