Shaneis Malouff Biography

Shaneis Malouff, Chief of Staff at Auraria Campus and a healthcare policy advocate, is renowned for her impactful leadership in healthcare equity legislation across seven states. With a BA in Allied Health from Metropolitan State University and an MS in Prosthetics & Orthotics from Loma Linda University, she is a board-certified provider excelling in healthcare and public policy.

At Auraria Campus, Colorado's largest university, Malouff oversees Marketing, Communications, and Strategy. In her first year, she supported securing \$80M in state capital funding for campus improvements and led the implementation of the campus's first strategic plan. She is now spearheading a 30% expansion of Auraria's Early Learning Center.

Malouff previously contributed significantly to Vail Health, enhancing healthcare access and launching vital programs during the COVID-19 pandemic, including Eagle County's first SANE and FNE programs and a Community Health initiative offering free preventive visits and Medicaid enrollment.

At the Colorado Department of Public Health and Environment, she established the Disease Control and Public Health Response Division's first Project Management Office, creating a strategic plan and dashboard system.

Her work has influenced legislation beyond Colorado, including House Bill 23-1136 and similar laws in Illinois, New Mexico, Maryland, Minnesota, and Arkansas. Malouff's innovative and dedicated leadership makes her a standout candidate for recognition.
